its obligation under this bond, and it does hereby waive notice of any such change,
extension of time, alteration or addition to the terms of the Contract or the call for bids, or
to the work, or to the specifications.

In the event suit is brought upon this bond by the Obligee and judgment is recovered, the Surety shall pay all costs incurred by the Obligee in such suit, including a reasonable attorneys' fee to be fixed by the Court.

If the District awards the bid, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.

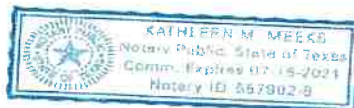

Ducts and duct banks shall be concrete encased where under vehicular roadways. Concrete slurry is available as an option to backfilling other trenches. Directional drilling will not be acceptable.

ITEM NO. 2: SECTION 26 0526 "GROUNDING AND BONDING FOR ELECTRICAL SYSTEMS" (NEW)

1. Add attached Section 26 0526 "Grounding and Bonding for Electrical Systems", which also applies to the grounding of the various metal fence sections.

1. As noted in the fencing legend on A-100, removal of fence post footings is required to facilitate installation of the new mow strip. Fence posts may NOT simply be cut off at grade with the footing left in place.

2. Clarification: Detail 14/A-700 shows a cast-in-place type v-track; this track may be pre-punched (before galvanizing) and installed with expansion anchors into the concrete footing/"mow strip".
