Item #1 of RFQ/P Clarification Addendum #2:

<u>Question:</u> The sample LLB agreement touches some on General Conditions but it is not a typical full General Conditions document. Will General Conditions be forthcoming before RFQ/P submittal date? *Answer: The specific General Conditions of the project will be provided to the selected contractors.*

Item #2 of RFQ/P Clarification Addendum #2: The contractor qualification have been revised to the following:

Reference: Contractors that intend to submit a response ("**Response**") to this RFQ/P must:

- Hold a Class B Contractors License which is current, valid, and in good standing with the California Contractors State License Board;
- Prequalify through the District's prequalification process at least <u>15 days before proposals are</u> <u>due</u>. Prequalification applications can be accessed at <u>https://www.oxnardunion.org/purchasing-</u> <u>warehousing/;</u>
- Register as a public works contractor with the department of Industrial Relations;
- Have completed at least one (1) Lease Leaseback project with an original contract value of \$50,000,000 or more during the past five (5) years and *at least two (2) Educational Project contracts with an original contract value of \$50,000,000 or more during the past ten (10) years and/or is pre-qualified with the Oxnard Union High School District for \$200,000,000 or more.*
